PRESIDENT'S CORNER



Crescit amor nummi, quantum ipsa pecunia crevi.

Sec. Uwe Koeller will preside our RCB meeting today. I trust that he will make a good OIC president as we reconcile with our Rotary initiative (under the CLP) to train our future club leaders.

Your president will be away today to join The Rotary Foundation Seminar in Balanga, Bataan. I have lost count as to how many times I have joined such a TRF District Seminar but remain hopeful that this trip will yield for us many happy returns—specifically in the interest of our RCB.

During this month of The Rotary Foundation, it is important for us to think as dedicated Rotarians and reconcile with our TRF givings. I am talking about each and everyone's participation to the Paul Harris Fellowship—as sustaining members onwards to full Fellowship. In the club, we can participate by supporting our club initiatives and buying two or three tickets to the PHF Raffle. My suggestion is for all our Rotarians to give/buy (as they say) "until it hurts."

Thank you to Manong Doming. But your president's option is to "stay" on our Invocation-Reflection. This is because we deem it far better to listen to a prepared PowerPoint Presentation and song—full of intent and meaning; rather than (very often) contend with someone reciting a litany of intentions which always redound to one and the same/typical enumeration. Often it becomes agonizing to last until the end of the "religious incantation"— which is actually the most basic no-no on the matter of good and real invocations. I trust that everyone will respect the option made. Besides, we do have a respite from the Invocation-Reflection agenda every last Saturday of each month (Family Day) when a full Invocation is opted for; and when your president is away—as in the case of the meeting today. Let PN Bert reconsider his options when he assumes the presidency next year.

While we are at it, allow me to explain my "take" on the *Pilipinas Kong Mahal* and why the "supposedly correct" final lyric of "hirang" is not opted for. The MP3 we use is actually a recording from the Mabuhay Singers (given as Asin on the Internet-retrieved file, but this is probably incorrect) who sing the whole song three (3) times on the original recording we obtained. I have opted to digitally splice (hinting at how much work was put in) the very last sequence of the whole song; and noted that the idealized lyric of "hirang" was not reall there. Not in the first, nor the second, nor the third singing by the Mabuhay Singers; each of the three repetitions of the song (in the version used) always ends with "mahal".

But what is wrong if we end with "mahal" and not with "hirang"? Singers do exercise "poetic license" (because songs are actually sung poems...) and have been known to change song lyrics with great abandon! Why make an issue with the "hirang"? Isn't "mahal" as strong a word as "hirang"? It is unfair to constantly comment and claim that "my" version is wrong because words in songs are never sacrosanct.

As I reconcile with all these, I actually say "thank you" to my detractor/s. They expect me/us to be perfect in everything—up to the last words on the *Pilipinas Kong Mahal*. But I say: let us not be too exacting and find fault with what we have. Let us instead sing the song properly in tune and with feeling!

Our Latin quotation for this week— *Crescit amor nummi, quantum ipsa pecunia crevi*, is from Juvenalis. It literally means: The love of wealth grows as the wealth itself grew. There is unquestionable truth to this axiom. Because man is an insatiable being, his thirst for material wealth is often unquenchable. To me, there is nothing inherently bad with seeking wealth. But what one does with his wealth will be the final matter. Suggestion: if you are a super-wealthy Rotarian—why not donate some of your extra cash to the TRF?

RCB-TOYA GUIDELINES

Search for RCB-TOYA

Rotary Club of Baguio's - Ten Outstanding Young Athletes

RATIONALE

To serve as an inspiration to the city as a whole and the sports community in particular by way of giving recognition to outstanding young athletes in the City of Baguio who have excelled in their respective sports/discipline—by giving honor and pride to their families, city and community.

CRITERIA

Nominees must possess the following:

- 1. Baguio-based athletes, with residence in the city or studying in any school, private or public, located in the City of Baguio.
- 2. Duly recommended or nominated by the president or officer-in-charge of his/her respective sports club or association.
- 3. Accomplishments or records (i.e. results of competitions-local and international) shall be based on the current year only—with certifications, photos, and news clippings as proof of record.
- 4. At least 24 years old or below, studying or out-of-school.

The foremost criterion will be on who performed well during the current year; id est- a silver medalist in any international competition beats a gold medalist in a local event.

GUIDELINES

A special TOYA SubCommittee shall be formed by the Rotary Club of Baguio to review the qualifications of the awardees: composed of the RCB president and two other RCB Rotarians. Mr. Jogin Rey Tamayo, RCB ally and acknowledged Baguio sportswriter, will serve as the overall adviser of this RCB SubCommitee. Jogin is tasked to spearhead the solicitation and acceptance of nominee records, pre-qualification, and submittal of a semi-final list of awardees and alternates. The RCB TOYA SubCommittee has the final say as to who will become the final awardees as TOYA. From among the ten awardees, the TOYA SubCommittee shall also vote for the Most Outstanding Athlete of the Year.

The search for the RCB-TOYA shall be held from September to November of the current year. A total of ten (10) athletes shall be chosen as the awardees; each winner shall receive a special Plaque of Recognition. The Most Outstanding Athlete of the Year will receive another plaque plus cash component.

AWARDING

This is set on the second Saturday of December (each year); this being a special and formal recognition occasion for the outstanding athletes. The awards luncheon shall be co-sponsored by the Baguio Country Club and the Rotarians of the RCB.

Please be informed that the **Annual Elections of the Board of Directors for RY 2008-2009 will be held on Saturday, 24 November 07,** as set by our Board. We enjoin every member to exercise his/her right of suffrage by being present during this important event, that of voting for our incoming board of directors and our President for 2009 - 2010.

In the event that any RCB member would not be able to attend the 24 November 07 meeting, he/she may avail of the right to **ABSENTEE VOTING**, as long as he/she submits his/her ballot, containing the names of **exactly 4 members** (no more, no less), to the Club Secretary, Dir. Uwe Koeller, **no later than 23 November 07.** Either personally or by mail / email. As per our amended ByLaws, Pres. Raffy Chan, PN Bert Talco (Chair, Com. On Administration), as well as Dir. Mia Cawed (Chair, Com. on Service Projects), Dir. Cecille Apostol (Chair, Com. on Membership), Dir. Dwight Dulnuan (Chair, Com. on Club Public Relations), & IPP Gerard Audineau (Chair, Com. on TRF), are automatically members of the incoming Board of Directors & therefore need not be voted upon.

From the seven directors, that is, the aforementioned committee chairs (except Pres. Raffy, PN Bert & IPP Gerard) plus the 4 RCB members garnering the highest vote on this date, the RCB President for RY 2009 - 2010 will be elected on this same day, immediately after the canvassing.

Here is a copy of our RCB By-laws provisions for elections, as amended and ratified on 11 November 06, for your perusal.

RCB BYLAWS (as amended & ratified 11 November 06)

Article I Election of Directors and Officers

Section 1 – At the annual meeting set by the board of Directors, all members in good standing, except the incumbent President and President-Elect, shall be voted upon and in the first year of the 3-Rotary year cycle, the eight (8) candidates securing the highest number of votes shall be declared elected into the Board of Directors for the incoming term. In the second and third year of the 3-Rotary year cycle, the four (4) candidates securing the highest number of votes during the elections for the respective year shall be declared elected into the Board of Directors for that respective year.

Any member who may be absent during the election of the Board of Directors may send his/her ballot by mail/delivered to the Club Secretary, and must be received at least one (1) day before the election. Any ballot received with less or more than eight (8) candidates voted (for the first Rotary cycle, four[4] for the 2nd & 3rd cycles) shall be VOID.

Section 2 – Election for President. Immediately after the election of the Board of Directors, the President shall be elected from among the elected Directors by a simple majority vote of all the club members in good standing present during the annual meeting. In case of a tie, a run-off election will be conducted until a President is elected. Past Presidents who are elected as Board of Directors are disqualified as candidates for President.

RCB COMELEC ADVISORY

The candidate elected for President shall be the President-nominee and shall serve as a Director and Chair of the Committee on Club Administration for the year commencing on the first day of July next following the election. He/she shall assume office as President for one (1) year, starting on the first day of July immediately following that year. The President-nominee shall take the title of President-elect upon the election of a successor.

Section 3 – Election of Vice-President. The Board of Directors shall elect among themselves the Vice-President from the Directors-elect remaining after the President has been elected, within one week after the annual meeting. He/she shall assume office for one (1) year, commencing on the first day of July next following the election.

Section 4 – The Club Secretary and Treasurer shall be appointed by the President-elect from the Directors-elect, subject to approval by the Board of Directors. They shall serve as assistant secretary/ treasurer starting January following their election as Directors, and assume office for one (1) year, starting on the first day of July.

Section 5 – The remaining four (4) Directors-elect shall be appointed by the President-elect, in consultation with the incumbent President and immediate Past President, as chairs of the Committees on Membership, Club Public Relations, Service Projects and Rotary Foundation. They will serve as chair of their respective committees for a maximum period of three (3) years. Should any of these Directors-elect be elected as an Officer in subsequent years of the 3-Rotary year cycle, his/her position shall be declared vacant and subject to Article I, Section 7 of these bylaws.

Section 6 – The Sergeant-at-Arms will be appointed by the President-elect from the Directors-elect or from the membership, subject to approval by the Board of Directors.

Section 7 – Any vacancy in the position of Officer-elect or Director-elect shall be filled by the candidate garnering the next highest place and in succession thereafter from the election results for Directors of the year in which the vacancy occurs.

Article II Board of Directors

The governing body of this club shall be the Board of Directors consisting of ten (10) members of this club, namely, the President, immediate Past President, and eight (8) Directors elected in accordance with Article I, section 1, of these by-laws, which include the President-elect, Vice-President, Secretary and Treasurer.




